

How to register your shares and file a proxy form

In order to cast your vote during the Annual General Meeting of Pharming on 20 May 2020 without attending the meeting in person (due to the COVID-19 pandemic) you are required to submit a proxy. To do this we ask you to take the following two steps **by 13 May 2020 18.00 at the latest:**

Step I:

- a. ***When your Shares are registered at ABN AMRO:*** notify ABN AMRO that you wish to attend the AGM of Pharming. This also applies if you are joining by webinar. Please choose one of the following options:
 - the most efficient way: use the portal via the following link: www.abnamro.com/evoting; (see note 1 for further instruction on abnamro's evoting)
 - call ABN AMRO's contact center at telephone number 0900-9215; or
 - send an e-mail to abnamro.depotbewijzen@nl.abnamro.com
- b. ***When your Shares are registered by another bank or another intermediary:*** ask them to inform ABN AMRO Corporate Broking as soon as possible that you wish to attend the AGM. This also applies if you are attending the webinar. Please ask them to use the following link: www.abnamro.com/intermediary

As confirmation of registration, you will receive from ABN AMRO or your own bank/intermediary a **registration certificate/admission ticket**. This admissions ticket is also necessary for attending the webinar.

Step II:

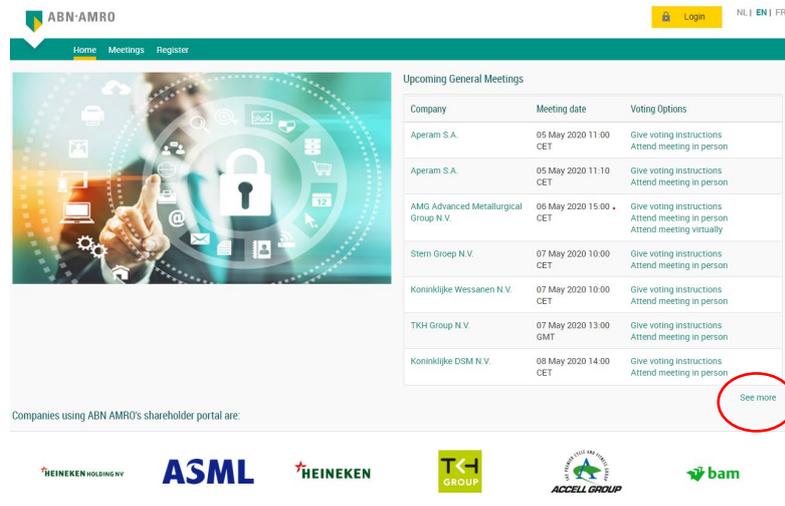
- a. Complete the attached proxy form (or download it from Pharming's website: www.pharming.com/investors/shareholdermeetings/proxy)
- b. Sign the proxy
- c. Send the signed proxy and a copy of the **registration certificate/admission ticket** (see step I) to the following e-mail address: investor@pharming.com
